NOTICE TO EXHIBITORS

Exhibitors, through submission of entry, acknowledge that they are knowledgeable of CKC rules and regulations, and agree to abide by all rules in effect at the time of this trial.

- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- After the closing date, NO entry fees will be refunded for dogs pulled from the trial -except for bitches that come into season before Thursday of the trial week in which case 50% of entry fees will be returned.
- Checks not honored by the bank do not constitute a valid entry fee. There will be a \$25.00 service charge for bank returned checks.

****Dog must be registered** and have a valid registration number before entries will be accepted.

Through submission of their entry, the exhibitors acknowledge they are familiar with CKC Official Event Rules.

General Agreement

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win points, prizes, ribbons, or trophies, I (we) agree to hold the Continental Kennel Club, Inc. (CKC), Louisiana Canine Team Builders Association, their members, directors, governors, officers, agents and/or the lesser of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any CKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of any dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at the time resulting there from, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such injuries, death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by negligence of the aforementioned parties or any of their employees, agents or any other persons. I (we) agree to follow and obey all rules, regulations, polices, procedures and guidelines as set forth by the CKC for this or any event and for the proper registrations of any dog or dogs competing in this or any event. I (we) agree that any videos, pictures or other likenesses taken at this event by CKC staff, representatives, or personnel, become the property of the CKC and may be used in any manner the CKC deems appropriate.
